A PUBLIC HEALTH EMERGENCY EXISTS DUE TO THE COVID-19 VIRUS PANDEMIC. THE STATE SURGEON GENERAL AND STATE HEALTH OFFICER DECLARED ON MARCH 1, 2020 THAT A PUBLIC HEALTH EMERGENCY EXISTS IN FLORIDA. ON MARCH 9, 2020, THE GOVERNOR DECLARED A STATE OF EMERGENCY FOR THE ENTIRE STATE AND THE EMERGENCY DECLARATION HAS BEEN EXTENDED BY SUBSEQUENT EXECUTIVE ORDERS. THE CDC HAS ISSUED RECOMMENDATIONS AND THE GOVERNOR HAS ISSUED MULTIPLE EXECUTIVE ORDERS, INCLUDING EXECUTIVE ORDER 20-69 (ALLOWING VIRTUAL MEETINGS), WHICH HAS BEEN EXTENDED BY SUBSEQUENT EXECUTIVE ORDERS. SCHOOL BOARD POLICY 1.09 ALSO ALLOWS BOARD ADVISORY COMMITTEE VIRTUAL MEETINGS UNDER THESE CIRCUMSTANCES.
