CONFERENCE ROOM A-306 AT FULTON-HOLLAND EDUCATIONAL SERVICES CENTER (FHESC) WILL BE PROVIDED WITH A SMART PANEL SO THAT ANY PUBLIC ATTENDEE MAY SIT IN A SOCIALLY DISTANT MANNER AND OBSERVE AND HEAR THE MEETING IN A SPACE THAT MEETS THE SCHOOL BOARD'S COVID-19 PROTOCOLS AS PROVIDED IN POLICY 2.065 "Visitation Protocols on District Property Due to COVID-19 - Emergency Policy". PLAN ON ARRIVING EARLY IN ORDER TO CLEAR SECURITY IN THE LOBBY. NOTE THAT YOUR TEMPERATURE MUST BE CHECKED AND YOUR CONTACT WITH INFECTED PERSONS INVESTIGATED VERBALLY TO BE ADMITTED. MASKS ARE REQUIRED DURING YOUR ENTIRE VISIT IN THE BUILDING. FHESC IS LOCATED AT 3300 FOREST HILL BLVD, CONFERENCE ROOM A-306, WEST PALM BEACH, FL, 33406. NOTE THAT NO STAFF MEMBERS WILL BE PRESENT EXCEPT TO VERIFY CONTINUING COMPLIANCE WITH MASK PROTOCOLS.

A PUBLIC HEALTH EMERGENCY EXISTS DUE TO THE COVID-19 VIRUS PANDEMIC. THE STATE SURGEON GENERAL AND STATE HEALTH OFFICER DECLARED ON MARCH 1, 2020 THAT A PUBLIC HEALTH EMERGENCY EXISTS IN FLORIDA. ON MARCH 9, 2020, THE GOVERNOR DECLARED A STATE OF EMERGENCY FOR THE ENTIRE STATE AND THE EMERGENCY DECLARATION HAS BEEN EXTENDED BY SUBSEQUENT EXECUTIVE ORDERS. THE CDC HAS ISSUED RECOMMENDATIONS AND THE GOVERNOR HAS ISSUED MULTIPLE EXECUTIVE ORDERS, INCLUDING EXECUTIVE ORDER 20-69 (ALLOWING VIRTUAL MEETINGS), WHICH HAS BEEN EXTENDED BY SUBSEQUENT EXECUTIVE ORDERS. SCHOOL BOARD POLICY 1.09 ALSO ALLOWS BOARD ADVISORY COMMITTEE VIRTUAL MEETINGS UNDER THESE CIRCUMSTANCES.

AS A RESULT, THE SCHOOL DISTRICT OF PALM BEACH COUNTY, FLORIDA, HEREBY GIVES NOTICE THAT THE FINANCE COMMITTEE WILL CONDUCT A VIRTUAL PUBLIC MEETING USING "GOOGLE MEET" TECHNOLOGY ON THE DATE LISTED ABOVE.

PUBLIC COMMENT OR OTHER PHYSICAL EVIDENCE WILL BE ACCEPTED IN WRITING ONLY BY EMAILING THE COMMITTEE LIAISON AT LEANNE.EVANS@PALMBEACHSCHOOLS.ORG BY NOON ON OCTOBER 29, 2020. PUBLIC COMMENTS ARE LIMITED TO 3 MINUTES (or approximately 400 words). ALL COMMENTS AND EVIDENCE WILL BE CONVERTED TO PDF FORMAT AND ATTACHED TO THE BOARDDOCSLT AGENDA FOR VIEWING BY COMMITTEE MEMBERS, SCHOOL BOARD MEMBERS, DISTRICT STAFF, LEADERSHIP, AND THE PUBLIC. ALL

COMMENTS AND EVIDENCE MUST INCLUDE THE PERSON'S NAME FOR THE RECORD. BEST EFFORTS WILL BE MADE TO ALSO INCLUDE COMMENTS AND EVIDENCE RECEIVED AFTER 5:00 P.M.
