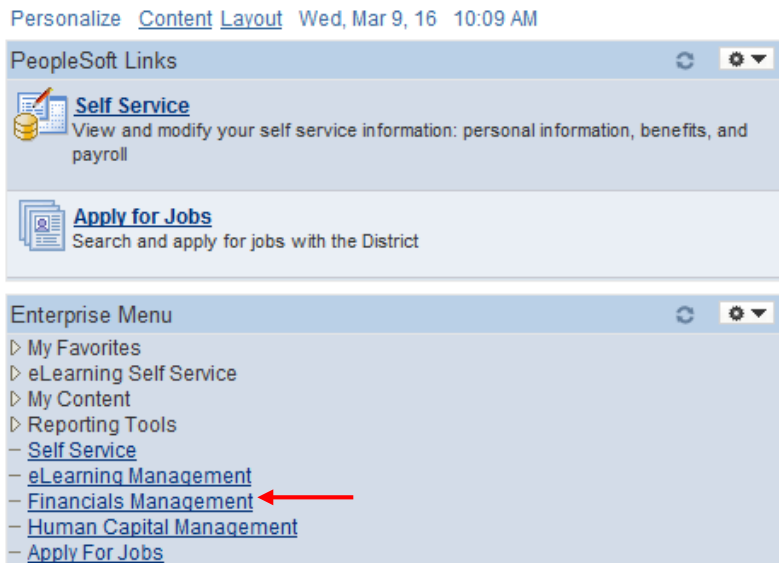
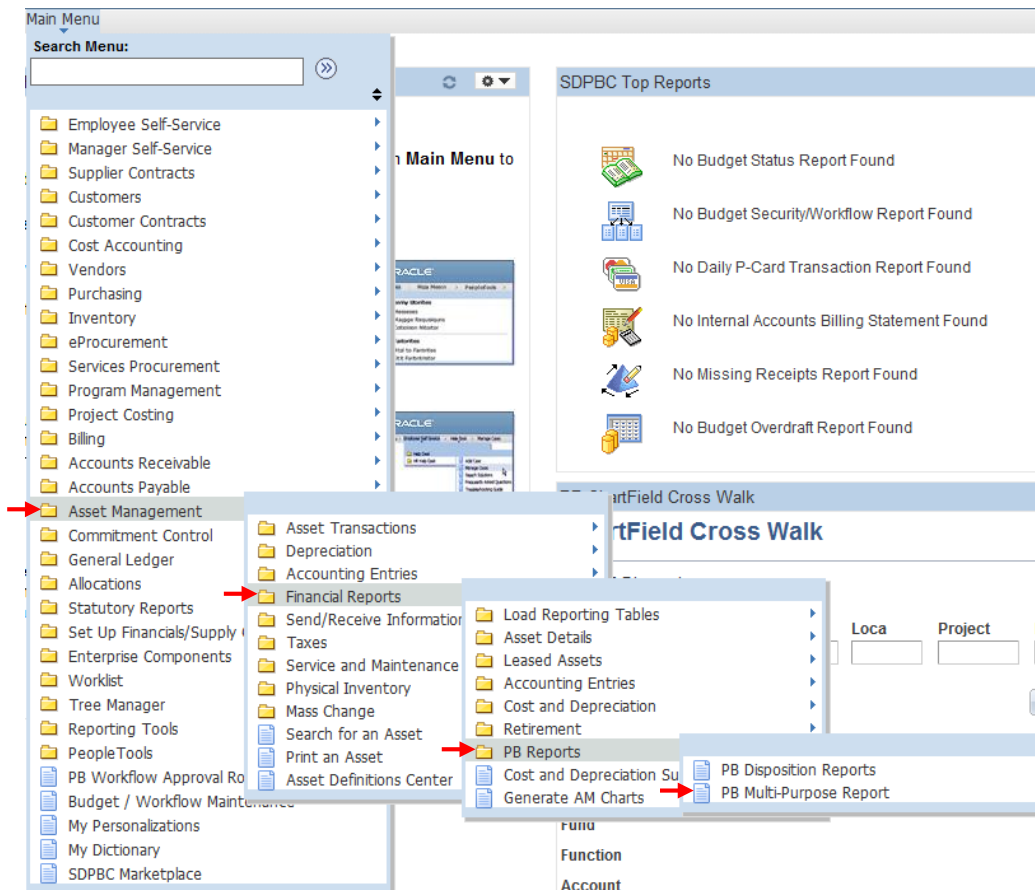


How to Run Asset Reports

- Login to PeopleSoft. Navigate to the Enterprise Menu and click on Financials Management



- On the top of the page, click on Main Menu → Asset Management → Financial Reports → PB Reports → PB Multi-Purpose Report



- In order to run a report, you have to establish a Run Control ID. If you think you have already have one, click on Search and see if anything comes up.
