On November 6, 2019, the OIG received an anonymous complaint alleging West Boca Raton Community High School teacher used the school's fields to hold practice and tryouts for his softball travel team without a lease or payment. The investigation concluded the allegation was unsubstantiated.

In accordance with School Board Policy 1.092 (8)(b)(iv), on April 23, 2020, the OIG sent the draft investigation report to did not submit a response.

INTRODUCTION & SYPNOPSIS

On November 6, 2019, the Office of Inspector General (OIG) received an anonymous complaint regarding the use of a School softball field by the head softball coach without a lease agreement and applicable payment. Specifically, it was alleged that West Boca Raton Community High School Teacher held practices on the School's softball field every Tuesday and Thursday for his travel softball team, Gold Coast Hurricanes, without a lease agreement or payment.

The OIG investigation concluded the allegation was unsubstantiated. The investigative findings of the allegation will be discussed in detail later in this report.

OIG JURISDICTIONAL AUTHORITY

School Board Policy 1.092 provides for the Inspector General to receive and consider complaints, and conduct, supervise, or coordinate such inquiries, investigations, or reviews, as the Inspector General deems appropriate.

BACKGROUND: INDIVIDUALS & ENTITIES COVERED IN THIS REPORT

West Boca Raton Community High School

West Boca Raton Community High School is located at 12811 Glades Road, Boca Raton, Florida 33498. Student enrollment is 2,190 serving grades 9-12.

Gold Coast Hurricanes Softball, Inc.

Gold Coast Hurricanes is a Florida Not For Profit Corporation consisting of various softball teams. One of the softball teams is "Gold Coast Hurricanes Thompson 16U." District employee, is one of the head coaches. The OIG interviewed volunteers, a parent, and a coach during the investigation.

City of Coconut Creek - Sabal Pines Park

Sabal Pines Park is located at 5005 NW 39th Ave. Sabal Pines Park has nine athletic fields which include softball fields.³

Bradly Dorfberger, Assistant Principal, West Boca Raton Community High School

Mr. Dorfberger has been a vocational Assistant Principal at West Boca Raton Community High School since September 2017.⁴

CASE INITIATION & INVESTIGATIVE METHODOLOGY

The investigation was initiated based on an anonymous complaint alleging that west Boca Raton Community High School's softball field every Tuesday and Thursday to hold practice for his softball travel team without a lease or payment. The complainant also reported that tryouts would be held at the School on December 22, 2019.

The OIG interviewed Assistant Principal Bradly Dorfberger and Teacher The OIG also interviewed some parents, another coach from the Gold Coast Hurricanes team, and a representative from Sabal Pines Park. The OIG reviewed applicable District Policies, PeopleSoft employee records, District lease records, and related social media posts.

This investigation was conducted in compliance with the *Quality Standards for Investigations*, *Principles and Standards for Offices of Inspector General*, promulgated by the Association of Inspectors General.

INVESTIGATIVE FINDINGS⁵

1. West Boca Raton Community High School teacher used the field at the School to hold practice and tryouts for his softball travel team without a lease or payment. Allegation Unsubstantiated.

The OIG investigation determined the allegation that used the School's field to hold practice and tryouts for his softball travel team without a lease or payment was unsubstantiated.

The following is a summary of testimonies from persons interviewed as indicated:
stated that he is a coach for the Gold Coast Hurricanes. confirmed there are 13 players and practice is held on Tuesdays and Thursdays from 7:30 – 9:30 PM at Lyons Creek Park in Coconut Creek, Florida. He stated that practice times and information are at times communicated through an application called "Group Mate". said he has a lease agreement with West Boca Raton Community High School; the lease agreement was not for any specific time or dates because it was for potential use. further stated the required insurance information was turned into the School, but no payments were made because the field was not used.
Assistant Principal Bradly Dorfberger: Mr. Dorfberger said that part of his job duties include overseeing the School leases. He added that Ms. Nancy McLoughlin ⁷ previously had the responsibility and still assists him with agreements. Mr. Dorfberger stated that to his knowledge, one of the School's softball fields is currently leased for soccer practice. He was not aware that coached a softball travel team. Mr. Dorfberger stated he has seen at the fields, but does not recall specific dates or times. Since is the School's softball coach, he did not think anything when he would see him on the fields. Mr. Dorfberger recalled seeing on the field occasionally, but not consistently. Since Mr. Dorfberger has job duties throughout the School, he is not always out on the fields. He stated he may have seen at the field once in November with a handful of kids, but did not recall seeing him on the field in December. Mr. Dorfberger confirmed that has never approached him regarding the use of the fields or leasing the field.
Mike Thompson: Mr. Thompson coaches the Gold Coast Hurricanes softball travel team with Mr. Thompson is not a District employee. Mr. Thompson said the team has practice on Tuesday and Thursday at Lyons Creek Park. When asked if the team has ever practiced at the fields located at West Boca High School, he said it may have happened once, but he did not recall when or if it was the same team name. Mr. Thompson explained that the team used to be named the Coral Springs Panthers prior to becoming Gold Coast Hurricanes. While they were the Panthers, Mr. Thompson worked with Ms. Nancy McLoughlin at West Boca High School to establish a lease for the use of the fields. ⁸ , but there were issues establishing the lease because of the insurance documentation. Mr. Thompson said he was under the impression the last insurance document he turned in (Mr. Thompson does not recall the date) was fine since he never heard back from Ms. McLoughlin.
Connie Young, Senior Staff Assistant, Sabal Pines Park: The OIG contacted the park's main line

Connie Young, Senior Staff Assistant, Sabal Pines Park: The OIG contacted the park's main line (954 545 6600) on April 16, 2020, at approximately noon and spoke with Senior Staff Assistant Connie Young. The OIG asked Ms. Young to confirm rental field dates used by the Gold Coast Hurricanes based on the information provided to the OIG by the parent volunteer. Ms. Young

provided confirmation that the park's softball fields were rented by the parent volunteer during August 18, 2019, through December 19, 2019, consistent with the receipts provided by the parent volunteer to the OIG. (**Exhibit 1**) provides a detailed list of the dates the fields were rented.

DOCUMENTATION REVIEWED

The OIG reviewed Tririga⁹ to determine if there was a lease agreement for Gold Coast Hurricanes travel softball team during School Year 2019-2020. The OIG did not find any record of a lease agreement in Tririga¹⁰.

The OIG determined the travel softball team has a Facebook account, "Gold Coast Hurricanes /Thompson". The Facebook account revealed the following posts regarding practice at West Boca Community High School:

08/11/19	Time Changes for workouts to August 13 and 15 at 6 PM at West Boca Community High School (Exhibit 4)

A parent volunteer responsible for ensuring the rental of the fields for team practices, provided the OIG with receipts reflecting rental payment information. The receipts encompassed field rental dates from August 18, 2019, through December 19, 2019 (**Exhibit 5**). The receipts reflected that, with exception of 3 weeks in September, the fields at Lyons Creek Park were rented consistently on Tuesday and Thursday from 7:30 – 9:30 PM between August and December 2019.

On April 1, 2020, at approximately noon, the OIG contacted the park via telephone and spoke with Senior Staff Assistant Connie Young. The OIG and Ms. Young reviewed each receipt provided by a softball parent volunteer to confirm its validity. The records reviewed on the phone with Ms. Young confirmed each date and time the parent rented the field.

It should be noted the receipts provided to the OIG reflect the parents name and the name "Florida Power Black travel team". The OIG inquired about this with the parent that provided the information. The parent explained that he managed the Florida Power Black travel team, but sometime in March 2019, his team merged with the Gold Coast Hurricanes. The Division of Corporations, the State of Florida's official business entity index and commercial activity website (Sunbiz.org), reflects Florida Power Black Inc. in which the parent was the President, is inactive; a dissolution was filed on September 27, 2019.

As mentioned above, the OIG located Facebook posts regarding August 7, 13, and 15, workouts at the School. The OIG inquired with two parent volunteers and Mr. Thompson regarding practices or workouts held at the School. Mr. Thompson and one parent volunteer stated that the team practiced once at the School, but neither could recall the date it took place. The other parent volunteer stated he had no recollection of any practices at the School.

Mr. Thompson provided the OIG with screenshots of the teams' group messenger reflecting the workout on August 7 was cancelled due to the weather, and stated it would be rescheduled for the following day at 6 PM (**Exhibit 6**). Mr. Thompson also provided evidence the scheduled August 13 practice was cancelled (**Exhibit 7**). Mr. Thompson said he did not have any information available regarding August 15. The screenshots provided did not reflect the location of the practice. The OIG inquired with the parent volunteer that posted the information on Facebook and the parent did not recall why the location was West Boca Community High School.

noted that two of the players on the travel team are students at the School. The OIG attempted to verify the location of practices with their parents. The OIG was able to communicate with one of the parents, who said that to their knowledge there have not been any practices at the School for the travel team. The parent also verified that practices are in Coconut Creek on Tuesday and Thursday evenings.

The OIG reviewed Tririga to determine if there were any other leases in place for the fields at the School during August and December 2019. The results revealed the fields were leased to three organizations during August and December, however none were leased on August 7, 13, or 15, 2019. Lease agreements typically require a charge for labor such as custodial work. However, since the dates in question took place during the school week, there would not be labor charges associated because the School is a Community School and therefore has custodians working until 10:30 PM.

Regarding the team holding tryouts at the School on December 22, 2019. The OIG located a post on Pitch2Fast.com dated December 6, 2019, with a subject line of "Location and Time Change Gold Coast Hurricanes / Thompson 16U- Summer 2020 Tryout" (**Exhibit 8**). The post states the location of tryouts are at Sunset Park in Plantation, Florida on January 12, 2020. During interview, he explained that the person that handles the administrative work for the travel team had initially posted on social media that the tryouts would be held at West Boca Raton High School on December 22, 2019, but he told them to correct it.

CONCLUSION

The OIG investigation concluded the allegation was **unsubstantiated**. The OIG did not find sufficient evidence that the team practiced at the School between August and December 2019. Rental receipts were provided to the OIG reflecting field rentals on Tuesday and Thursday in Coconut Creek, Florida commencing on August 18, 2019, and ending on December 19, 2019. The OIG also confirmed with Sabal Pines Park Senior Staff Assistant Connie Young the dates the fields

were rented and used by Gold Coast Hurricanes, consistent with the rental dates provided by the parent. As stated by a parent and Mr. Thompson, they recall one practice took place at the School, but they did not recall the date or time. As demonstrated above, the OIG found social media posts reflecting that workouts were scheduled to take place at the School in August 2019. However, Mr. Thompson provided screenshots reflecting two of those events were cancelled due to weather restrictions. While the screenshots do not reflect the location of the workouts, it is possible that there were plans for the team to hold workouts at the School on those particular days as reflected on social media, but there is no concrete evidence to prove that they actually took place or when. The OIG attempted to find evidence through other possible avenues such as other leases, labor charges and the School's calendar, but there was no evidence to support the allegations.



The evidentiary standard used by the School District of Palm Beach County OIG in determining whether the facts and claims asserted in the complaint were proven or disproven is based upon the preponderance of the evidence. Preponderance of the evidence is contrasted with "beyond a reasonable doubt," which is the more severe test required to convict a criminal and "clear and convincing evidence," a standard describing proof of a matter established to be substantially more likely than not to be true. OIG investigative findings classified as "substantiated" means there was sufficient evidence to justify a reasonable conclusion that the actions occurred and there was a violation of law, policy, rule, or contract to support the allegation. Investigative findings classified as "unfounded" means sufficient evidence to justify a reasonable conclusion that the actions did not occur and there was no violation of law, policy, rule, or contract to substantiate the allegation. Investigative findings classified as "unsubstantiated" means there was insufficient evidence to justify a reasonable conclusion that the actions did or did not occur and a violation of law, policy, rule, or contract to support the allegation could not be proven or disproven.

Below is a list of dates the fields were rented by Gold Coast Hurricanes. This information was derived from rental payment receipts provided by a parent volunteer. On April 16, 2020, the OIG confirmed the dates and times with Sabal Pines Park Senior Staff Assistant Connie Hughes. The information provided was consistent with the receipts provided by the parent volunteer.
