## SUBJECT: RESULTS OF FY22 FLORIDA STANDARDS ASSESSMENTS (FSA) AND END-OF-COURSE (EOC) ASSESSMENTS BY SUBGROUPS

The Florida Department of Education (FDOE) released the FY22 results of the Florida Standards Assessments (FSA) for English Language Arts (ELA) and Mathematics, Statewide Science Assessments, FSA End-Of-Course (EOC) Assessments for Algebra 1, Geometry, and Next Generation Sunshine State Standards (NGSSS) EOC Assessments for Biology 1, U.S. History, and Civics.. ${ }^{1}$ The present document summarizes the FY19, FY21, and FY22 data by subgroup, with a focus on post-pandemic change from FY21 to FY22. Nearly all student groups exhibited a decline in performance from FY19 (pre-pandemic) to FY21 (first year of testing post-pandemic). However, a preliminary analysis revealed instances of improved performance in this second year of post-pandemic testing. ${ }^{2}$ Student successes are outlined below.

- English Language Arts
- Nearly one-third of the subgroups (38\% of comparisons) showed improvement in FY22 relative to FY21. Among the groups showing improvement were:
- English Language Learners (ELL) in grades $3(+3.6), 4(+12.9), 5(+4.5), 6(+6.3), 7(+3.8)$, and 10 (+4.8);
- Students with Disabilities (SWD) in grades 4 (+9.4), 9 (+4.9), and 10 (+3.4);
- Free or Reduced Lunch (FRL) in grades $4(+12.1)$, 7 (+2.3), and 9 (+3.9);
- Black students in grades 4 (+14.1) and 9 (+5.2);
- Hispanic students in grades $4(+10.6)$ and $7(+2.3)$;
- White students in grade 4 (+2.9);
- Male students (overall) in grades 5 (+10.3), 7 (+2.2), and 9 (+2.3); and
- Female students (overall) in grades $4(+9.8)$ and $9(+2.7)$.

a Among Black students, males showed substantial improvement in grades 4 (+13.7), 7 $(+2.8)$, and $9(+6.0)$; females in grades $4(+14.2)$ and $9(+4.2)$.

- Among Hispanic students, males showed substantial improvement in grades 3 (+2.4), 4 (+10.5), and 7 (+3.3); females in grades 4 (+10.7) and 9 (+2.4).
- Gaps between Black and White students decreased in grades 4 (-11.2) and 9 (-4.4); the gap between Hispanic and White students decreased in grade 4 (-7.7).
- Mathematics
- Improvement was shown among most groups (86\% of comparisons) in FY22 relative to FY21.
- All groups showed improvement in grades $3(+8.7), 4(+12.9), 6(+5.6), 7(+6.2)$, and 8 (+8.8).
- In grade 5, improvements were found among ELL (+2.8) and White Female (+3.3) students.
- Gaps between Black and White students decreased in grades $4(-11.6)$ and $8(-4.1)$; the gap between Hispanic and White students decreased in grade 4 (-7.3).
- Science
- Performance in Science remained stable for most groups from FY21 to FY22.
- ELL students in grade 5 improved (+4.4) overall and among both females (+4.6) and males (+4.4).
- End of Course Exams
- Nearly all subgroups improved in Algebra 1 (+3.8), Geometry (+7.7), Civics (+5.0), and U.S. History (+4.8).
- ELL students showed improvement in Biology 1 (+3.1).
- Gaps decreased between Black and White students in Civics (-3.2) and U.S. History (-3.3).
- Gaps decreased between Hispanic and White students in Algebra 1 (-3.0) and Civics (-3.6).

## Next Steps and Guiding Questions

Now that schools have the FSA results by demographic subgroup, what are the next steps? Schools should review these results to determine strengths to build upon and explore opportunities for growth. While reviewing these data, schools should be mindful of the following:

1. Which subgroups are demonstrating higher/lower achievement rates?
2. How consistent are those patterns over time? Across grade levels?
3. How do those patterns compare to State/District patterns?
4. Are these patterns consistent with other classroom data we have about our students?
5. How are we assigning our highest/lowest subgroups across classrooms?
6. How are we aligning our resources and allotments to support our neediest subgroups?
[^1]These results will be shared with appropriate staff to provide direction for improvement in curriculum and instruction. In addition, schools have received reports regarding their FSA and EOC test takers and will use this information in the school improvement planning process.
