Application Processing Time is 30-60 days

LOCATION

- Independent, free-standing businesses at a physical address (including home offices)
- Headquartered in Palm Beach, Broward, or Miami -Dade

OWNERSHIP

- Established & operational for at least one full year prior to application
- 51% owned & operated by a minority or woman

QUALIFICATIONS

- Owner must submit a resume showing appropriate experience
- Hold all required state/local licenses
- The minority or woman must be the licensor/qualifier for the business


REVENUE CAPS

Average of 3 years of gross receipts

- \$6MM for professional services
- \$7MM for commodities
- \$13MM for Construction
- \$2MM for professional services
- \$3MM for commodities

Proof of stock purchase; Copies of third party agreements such as rental or management service agreements, etc. Copy of last annual statement filed with the Florida Secretary of State Division of Corporation.
