**\*NOTES:**

**Maintains positive financial trends** – While the financial indicators for the Fund Financial Statements show positive increases, this appears in part due to financing activities (PPP Loans \$198,800) not from regular operations.

**Maintain adequate fund balance** – As with the note regarding positive financial trends, even though general fund balance showed an increase throughout the year, it was due in part to financing activities.

**COVID-19** - In March 2020, the World Health Organization declared the outbreak of a coronavirus (COVID 19) a pandemic. As a result, the local and global financial markets are experiencing significant declines and creating economic uncertainties. At this time, it is unknown precisely how this negative outlook will impact the School’s financial statements in the future.
